

## SES Leadership Seminars: Onboarding for New Senior Executives Driving Results-Oriented Performance Cultures



Government executives need to achieve mission results amidst fiscal stress, competing priorities, and demands to be innovative and value-added. In this session, you will interact with public and private sector leaders as they describe what it takes (individually and collectively) to create, transform, measure, and sustain corporate and agency cultures that effectively execute on the goals they set. **Location:** The seminar will be held at the Commodity Futures Trading Commission (CFTC) Conference Center at 1155 21st Street, NW, Washington, DC 20581. The building entrance is on 21st Street NW between L and M Streets. The seminar will be held in the Conference Center, which is located on the first floor. Attendees must show government-issued identification to access the CFTC Conference Center.

**Directions:** Go to <http://g.co/maps/gfzhc> and insert your departure address. Proceed straight upon entering main lobby through security where you will be directed to the Conference Center.

The CFTC is located near three Metro stations: Farragut North (Red Line), Dupont Circle (Red Line), and Foggy Bottom (Blue/ Orange Line). Daily garage parking is available at the CFTC and there are several additional garages nearby; prices range from \$11 - \$20 per day.
